The GATE 2021 score is calculated using the formula

$$GATE\ Score = S_g + (S_f - S_g) \frac{(M - M_g)}{(M_f - M_g)}$$

where,

$M$  is the marks obtained by the candidate in the paper, mentioned on this GATE 2021 scorecard

$M_g$  is the qualifying marks for general category candidates in the paper

$M_f$  is the mean of marks of top 0.1% or top 10 (whichever is larger) of the candidates who appeared in the paper (in case of multi-session papers including all sessions)

$S_g = 350$ , is the score assigned to  $M_g$

$S_f = 900$ , is the score assigned to  $M_f$

In the GATE 2021 score formula,  $M_g$  is 25 marks (out of 100) or  $\mu + \sigma$ , whichever is greater. Here  $\mu$  is the mean and  $\sigma$  is the standard deviation of marks of all the candidates who appeared in the paper.
